RESOLVED, that pursuant to the information contained in Docket No. CI-Section 508(h) Submission Annual Forage Rainfall Index User Fee Request 09-21-16 01, Exhibit 4382, as well as other material that were submitted to the Board on this matter, the Board hereby approves the user fee of 3.3 percent of premium, up to an annual maximum of \$250,000, as submitted, for the Annual Forage Rainfall Index plan of insurance beginning with the 2017 insurance year.

There being no discussion, the Board voted to approve. (Exhibit 4282)

Robin Anderson, Secretary to the Board then read the following statement (Exhibit 4383):

The Board is responsible for determining whether requests for reimbursement and user fees are reasonable. The Board had previously issued procedures for determining the reasonableness of reimbursement expenses in 2010, but this Board has concluded that such procedures do not require reporting of sufficient information with respect to research and development, maintenance, and user fees. As a result, the Board will be revising its procedures to require more meaningful information that will allow it to better assess the work required and whether the hours, wage, and rates claimed to accomplish that work are reasonable.

There being no further business the Board voted to adjourn and to meet again November 15-17, 2016, in Washington, DC.
