In accordance with Section 3 of the Group Risk Income Protection (GRIP) Plan Crop Provisions, approved final county yields and county revenues for 2013 crop year wheat will be available in the ADM and posted on the RMA website listed below by close of business today.

In some situations, the National Agricultural Statistics Service (NASS) was unable to provide a county estimate on the same basis as the GRP or GRIP offer available.

GRP Special Provisions for the 2013 crop year state: *If NASS is unable to provide a yield used to determine the payment yield on the same basis as the expected county yield described in the actuarial documents, RMA will determine the payment yield.*

GRIP and GRIP-HRO Special Provisions for the 2013 crop year state: *If NASS is unable to provide a yield used to determine the final county yield on the same basis as the expected county yield described in the actuarial documents, RMA will determine the final county yield.*

### Description of RMA Determinations by GRP/GRIP Offer (Includes information reported to RMA as of March 26, 2013)

**Winter Wheat / Total for Crop / Planted Yield** - calculated as the acre-weighted average of 2013 wheat yields reported to RMA as actual yields by crop insurance program participants in the county. If a participant was found to have un-harvested acreage claim(s) in 2013, appraised production from these claims was deducted.

**Winter Wheat / Total for Crop / Harvested Yield** - calculated as the acre-weighted average of non-zero 2013 wheat yields reported to RMA as actual yields by crop insurance program participants in the county. If a participant was found to have un-harvested acreage claim(s) in 2013, acreage and appraised production from these claims was deducted.

**Winter Wheat / Irrigated / Harvested Yield** - calculated as the acre-weighted average of non-zero 2013 irrigated wheat yields reported to RMA as actual yields by crop insurance program participants in the county. If a participant was found to have un-harvested acreage claim(s) in 2013, acreage and appraised production from these claims was deducted.

**Winter Wheat / Non-Irrigated Total / Harvested Yield** - calculated as the acre-weighted average of non-zero 2013 non-irrigated wheat yields reported to RMA as actual yields by crop insurance program participants in the county. If a participant was found to have un-harvested acreage claim(s) in 2013, acreage and appraised production from these claims was deducted.
