Description of RMA Determinations (Includes information reported to RMA as of July 8, 2015)

Total for Crop / Planted Yield - calculated as the acre-weighted average of 2014 yields reported to RMA as actual yields by crop insurance program participants in the county for the given commodity.

Irrigated Total / Planted Yield - calculated as the acre-weighted average of 2014 irrigated yields reported to RMA as actual yields by crop insurance program participants in the county for the given commodity.

Non-Irrigated Total / Planted Yield - calculated as the acre-weighted average of 2014 non-irrigated yields reported to RMA as actual yields by crop insurance program participants in the county for the given commodity.
