Subject: Vomitoxin in Wheat — Salvage Markets

BACKGROUND

Weather conditions this year have made vomitoxin a threat to this year's wheat crop in Colorado, Kansas, Missouri, and Nebraska. High levels of vomitoxin may result in either a discount in price or the requirement to destroy the grain altogether.

ACTION

Approved Insurance Provider's (AIP) have requested a list of potential salvage markets for damaged grain. Below is a list of damaged grain buyers. This list is not complete and is provided as a guide to assist the AIP in locating salvage markets.
