2013 COMMODITY INSURANCE FACT SHEET

Corn

CT, DE, MA, MD, ME, NH, NJ, NY, NC, PA, RI, VT, VA, WV

Crop Insured

The crop insured will be all corn grown in the county on insurable acreage, for which premium rates are provided either as for grain or silage, in which you have a share. Corn for grain or silage may be covered with yield protection or revenue protection. The Risk Management Agency will set the silage harvest price equal to the projected price.

Production Guarantee

- 1) **Yield Protection Plan:** provides protection against production losses.
- 2) **Revenue Protection Plan:** provides protection against loss of revenue due to a production loss, price decline or increase, or a combination of both.
- 3) **Revenue Protection with Harvest Price Exclusion Plan:** provides protection against loss. Revenue caused by price decrease, low yield or a combination of both based on the projected price only.

Note: Beginning in 2013, Trend-Adjusted APH Yield Option is available for corn. The Trend-Adjusted APH Yield Option adjusts yields in APH databases to reflect increases in yields through time in the county. Trend adjustments are made on each eligible yield within a qualifying APH database based on the county's historical yield trend that is provided in the county actuarial documents. The approved APH yield is calculated using trend-adjusted yields, and any other applicable yields, within the APH database. It may not be available for all practices, and the factor may vary by practice. This option is not available with CAT, Group Risk Protection, and Group Risk Income Protection insurance plans.

Causes of Loss

Adverse weather conditions¹
Failure of irrigation water supply²
Fire
Insects³
Plant disease³
Wildlife

¹Natural perils such as hail, freeze, frost, drought, wind, and excess precipitation.

²If caused by an insured peril during the insurance period.

³Except for insufficient or improper application of control measures.

Insurance Period

Insurance coverage begins on the later of the date we accept your application or the date when the crop is planted, and will end at the earliest of:

- 1) Total destruction of the crop;
- 2) Harvest of the unit;
- 3) Final adjustment of a loss;
- 4) Abandonment of the crop; or
- 5) October 20 for silage and December 10 for grain.

Reporting Requirements

You must file a report of planted acreage to your crop insurance agent by the acreage reporting date established for your county. Since acreage reporting dates vary by crop and county, consult your agent or for more information see: <http://www.rma.usda.gov/tools/>

Duties in the Event of Damage or Loss

- 1) Protect the crop from further damage by providing sufficient care;
- 2) Notify your agent within 72 hours of your initial discovery of damage (but not later than 15 days after the end of the insurance period); and
- 3) Leave representative samples intact for each field of the damaged unit.

Coverage Levels and Premium Subsidies

The premium subsidy percentages and available coverage levels are shown below. Your share of the premium will be 100 percent minus the subsidy amount.

Catastrophic Risk Protection (CAT) coverage is fixed at 50 percent of your average yield and 55 percent of the price election. The cost for CAT coverage is an administrative fee of \$300.

Price Elections

Commodity Exchange Price Provisions (CEPP) contains information necessary to derive the projected price and the harvest price for the insured crop. The projected price is used to calculate the premium, re-plant payment and any prevented planting payment. The harvest price will be used to value production-to-count under the Revenue Protection Plan and the Revenue Protection with Harvest Price Exclusion plans. The CEPP includes the price discovery period, release dates, board of trade used, and additional pricing information. Insurance Units

Basic Unit: A basic unit includes all of your insurable small grains acreage in the county by crop by share arrangement. Premiums are reduced 10 percent for a basic unit.

Optional Unit: If a basic unit consists of 2 or more Farm Service Agency farm serial numbers and certain record keeping requirements are met, you may qualify for optional units. The 10 percent premium discount will not apply.

Enterprise Unit: Generally, all the insured acreage of the crop in a county. Premium discounts and additional subsidy apply.

Whole Farm Unit: Generally, all the insured crops in the county that are covered by the insurance plan. Premium discounts and additional subsidy apply. Does not apply to Yield Protection Plan.

Late and Prevented Planting

These provisions provide protection on acreage planted after the final planting date or that cannot be planted. Please consult a crop insurance agent for details.

Loss Example

Assume corn with an approved yield of 90 bushels per acre, 75 percent coverage level, \$5.29 projected price, \$4.49 harvest price, and 40 bushels produced.

Yield Protection

Revenue Protection

$$\begin{array}{r} 90 \\ \text{APH Yield per acre} \\ \text{Coverage Level} \quad \times .75 \\ \hline \text{Acre Guarantee} \quad 67.50 \\ \text{Projected Price} \quad \times \$5.29 \\ \hline \text{Insurance Guarantee} \quad \$357.08 \end{array}$$

$$\begin{array}{r} 40 \\ \times \$5.29 \\ \hline \$211.60 \end{array}$$

$$\begin{array}{r} 40 \\ \text{Bushels Produced} \\ \text{Harvest Price} \quad \times \$4.49 \\ \hline \text{Production-to-Count Value} \quad \$179.60 \end{array}$$

$$\begin{array}{r} \$357.08 \\ -\$211.60 \\ \hline \$145.48 \end{array}$$

$$\begin{array}{r} \text{Insurance Guarantee*} \quad \$357.08 \\ \text{Production-to-Count Value} \quad -\$179.60 \\ \hline \text{Indemnity/Acre} \quad \$177.48 \end{array}$$

*For Revenue Protection, the insurance guarantee is equal to the production guarantee multiplied by the greater of the projected price or the harvest price. In example, Revenue Protection harvest guarantee increased to \$357.08 (67.5 bushels per acre guarantee x \$5.29 projected price).
