All other type 10 and type 14 records (non-assigned risk) to be timely-processed and to facilitate the pollicy holder tracking system (PHTS) must be submitted to and accepted by FCIC within 45 days after the earliest sales closing date for the crop(s) in the county.

Valid information in fields 2 through 9, field 16 and field 24 is required to properly store fund designation data.
