Flag cannot be modified after the cut-off date for the location state/county (if crop does not exist in the Location State/County the cut off date will be based on the approved rate state/county) as follows:

If the Fund Designation Flag = 1, the assigned risk cut-off date is 30 days after the earliest sales closing date for the crop in the location county reported. A crop designated to the Developmental Fund may be transferred to the assigned risk fund with a flag of "8". For Nursery (0073), the company must designate eligible crop insurance contracts to the Assigned Risk Fund not later than the transaction cutoff date for the week including the 30th calendar day after the insured's signature date in field 26.

If the Fund Designation Flag = 2, (Cat Only) the assigned risk cut-off date is 30 days after the earliest acreage reporting date for the crop in the location county reported.

If the Fund Designation Flag = 3, DQS may manually place in the Assigned Risk Fund, after review if later than 30 days after the sales closing date.

If the Fund Designation Flag = 9 and the Carryover Contract = 1, the developmental

fund designation must be made not later than 30 days after the transaction cutoff date for the week containing the contract change date for the applicable crop and plan of insurance for each reinsurance year. If the contract change date occurs before July 1, the designation must be made by the cutoff date for the week including August 1.

If the Fund Designation Flag = 9 and the Carryover Contract = 0, the developmental fund designation must be made not later than the transaction cutoff date for the week containing the 30th day after the earliest sales closing date for the applicable crop and plan of insurance for each reinsurance year. For Nursery (0073), the company must designate eligible crop insurance contracts to the Developmental Fund not later than the transaction cutoff date for the week including the 30th calendar day after the insured's signature date in field 26.

If a type 14 record fails validation, all other type 14 records, type 15 records, type 11 records, and type 21 records will be rejected for the crop policy which failed.

All other type 10 and type 14 records (non-assigned risk) to be timely-processed and to facilitate the pollicy holder tracking system (PHTS) must be submitted to and accepted by FCIC within 45 days after the earliest sales closing date for the crop(s) in the county.

Valid information in fields 2 through 9, field 16 and field 24 is required to properly store fund designation data.
