The T-13 will match to the T-14 on fields 2 thru 9 and field 12 (practice) for Nursery if provided.

Only one 'Z' record for the Crop/County is allowed unless Nursery.

Nursery can have one 'Z' record with no practice or two 'Z' records for both practices or one 'Z' record for a practice and regular (insurable) T-13s for other practice.
