## **Hybrid Seed Price Endorsement**

The following 2015 CY hybrid seed corn prices have been approved for the Hybrid Seed Price Endorsement: **\$4.15 per bushel** for the non-organic practice; **\$7.81 per bushel** for the certified organic practice. These amounts reflect the higher values of either: 1) the previously-released 2015 crop year MPCI hybrid seed corn price elections [non-organic practice: \$3.74 per bushel; certified organic practice: \$6.88 per bushel]; or 2) the futures-based price derived from the average daily settlement price in February for the 2015 December CBOT corn contract [non-organic practice: \$4.15 per bushel], multiplied by an organic corn price factor [certified organic practice: \$7.81 per bushel].
