**Total for Crop / Planted Yield** - calculated as the acre-weighted average of 2014 yields reported to RMA as actual yields by crop insurance program participants in the county for the given commodity.

**Total for Crop / Harvested Yield** - calculated as the acre-weighted average of non-zero 2014 yields reported to RMA as actual yields by crop insurance program participants in the county. If a participant was found to have un-harvested acreage claim(s) in 2014, acreage and appraised production from these claims was not included to assure yields were on a harvested basis consistent with the insurance offer.

**Irrigated Total / Harvested Yield** - calculated as the acre-weighted average of non-zero 2014 irrigated yields reported to RMA as actual yields by crop insurance program participants in the county for the given commodity. If a participant was found to have un-harvested acreage claim(s) in 2014, acreage and appraised production from these claims was not included to assure yields were on a harvested basis consistent with the insurance offer.

**Non-Irrigated Total / Harvested Yield** - calculated as the acre-weighted average of non-zero 2014 irrigated yields reported to RMA as actual yields by crop insurance program participants in the county for the given commodity. If a participant was found to have un-harvested acreage claim(s) in 2014, acreage and appraised production from these claims was not included to assure yields were on a harvested

basis consistent with the insurance offer.
