2019 ADM Price updated for contract price indicator flag set to 'CP' on Alfalfa Seed (0107/plan 90 & 31), 6/30 filing.

2018 Margin Protection (MP) now has "yield year" of 2017 records populated on ADM Historical Yield Trend (61 rows) for Rice, 11/30 filing.
