#### **Crop Insurance Deadline Nears in Virginia**

### **Clam Producers Need to Make Insurance Decisions Soon**

RALEIGH, N.C., Oct. 29, 2021 — The USDA's Risk Management Agency (RMA) reminds Virginia clam producers that the final date to apply for crop insurance coverage for the 2022 crop year is November 30. Current policyholders who wish to make changes to their existing policies also have until November 30 to do so.

Crop insurance provides coverage for death of clams due to protected causes of loss such as oxygen depletion, disease, freeze, hurricane, decrease of salinity, tidal wave, storm surge, and ice floe. Coverage for clams is available in select counties. Additional information can be found on the <a href="Actuarial Information Browser">Actuarial Information Browser</a> page on the RMA website.

Growers are encouraged to visit their crop insurance agent soon to learn specific details for the 2022 crop year. Additional counties may be eligible for coverage under a written agreement. Crop insurance coverage decisions must be made on or before the sales closing date.

RMA is authorizing additional flexibilities due to coronavirus while continuing to support producers, working through Approved Insurance Providers (AIPs) to deliver services, including processing policies, claims and agreements. RMA staff are working with AIPs and other customers by phone, mail and electronically to continue

supporting crop insurance coverage for producers. Farmers with crop insurance questions or needs should continue to contact their insurance agents about conducting business remotely (by telephone or email). More information can be found at farmers.gov/coronavirus.
