Hurricane Insurance Protection - Wind Index (HIP-WI) Updated National Oceanic and Atmospheric Administration (NOAA) Climate Prediction Center (CPC) Rainfall Dataset August 2024

In accordance with Section 8(d) of the HIP-WI Endorsement and the Hurricane Data Provisions, the Risk Management Agency (RMA) reviewed the NOAA CPC dataset and preformed a re-analysis of the 2024 cyclones up to August 31, 2024.
