Commodity Exchange Price Provisions for the 2016 and Succeeding Crop Years – November Update

Background

The Commodity Exchange Price Provisions (CEPP) are used in conjunction with either the Common Crop Insurance Policy Basic Provisions or the Area Risk Protection Insurance Basic Provisions, and along with Crop Provisions for the following crops: barley, canola/rapeseed, corn, cotton, grain sorghum, rice, soybeans, sunflowers and wheat.

The CEPP specifies how and when the projected and harvest price components will be determined. The CEPP contains two sections:

1. Section I: General Information. This section contains information relevant for all applicable crops, including definitions and common policy materials.

2. Section II: Price Definitions. This section contains crop-specific projected and harvest price definitions and specifications, including commodity exchanges, contracts and discovery periods used in establishing the price.

• Section II: Sunflowers

• Section II: Wheat #

CEPP documents denoted above (#) were previously updated in June 2015. All CEPP documents not listed above are carried over from last year and applicable for the 2016 and succeeding crop years.
